Job Description

Lead Licensed Clinical Social Worker (LCSW)

The Lead Licenses Clinical Social Worker (LCSW) is responsible for providing initial evaluations, individual and/or family, therapy to TFCF clients as well as behavioral health consultation. In addition, the LCSW is responsible for supervising program staff, ensuring case managers are working with clients to develop case plans that address their barriers to securing and maintaining housing, and mitigates all staff and client issues to ensure the program is operating efficiently.

MANAGEMENT RESPONSIBILITIES:

- 1. Monitor and coordinate program staff attendance and schedule in accordance with client needs, assessment of positions
- 2. Oversee educational classes/groups and front desk/reception area
- 3. Ensure all clients are receiving certificates of completion for TFCF outpatient program, classes/groups, and incentives monthly
- 4. Ensure housing facilities are maintained and well-kept by monitoring daily/weekly house checks
- 5. Seek and create collaborative opportunities with local non-profits to increase client resources
- 6. Review weekly HMIS client log and CRM system information to ensure accuracy
- 7. Assist Program Manager with the implementation of program evaluation and management including client satisfaction surveys and overview of current programs

LCSW Responsibilities:

- 1. Observe client behavior, assess needs, and create treatment strategies
- 2. Diagnose psychological, behavioral and emotional disorders
- 3. Develop and put treatment plans in place
- 4. Consult with doctors, therapists and medical professionals
- 5. Administer social service programs
- 6. Charting and maintaining confidential client files and records which includes entering progress notes (filed within 24 hours) documenting the content of contact with the client or with the collateral sources for the client
- 7. Develops support systems to meet client needs by identifying and coordinating a variety of available services necessary to maintain independent living, family stabilization and self-sufficiency.
- 8. Conduct initial mental health evaluations resulting in realistic treatment plans
- 9. Assess clients using standardized assessment/screening tools, measures, etc.
- 10. Provide brief, solution-focused therapy
- 11. Provide group psychoeducation/treatment related to chronic medical conditions.
- 12. Provide information and referral services
- 13. Provision of other services related to wellness
- 14. Document services provided in accordance with requirements
- 15. Provide individual psychotherapy with children, adults, and families
- 16. Other duties as assigned

Qualifications:

- 1. Computer Literate in the following: Microsoft Word, Excel, Outlook, and emails. Must be able to demonstrate proficiency.
- 2. State and Federal laws and regulations on confidentiality, HIPPA, and other government standards.
- 3. Community resources and counseling/social work practices with high-risk populations and working with persons in crisis.
